After the above allotments of 2,00,00,000 equity shares of Re. 1/- each, the paid-up equity share capital of the Company stands increased from Rs. 7,26,73,170/- to Rs. 9,26,73,170/- divided into 9,26,73,170 Equity Shares of Re. 1/- each. 3. As per SEBI Order dated 11.01.2016, shareholding of Mr. Shreyas Sharma and Ms. Shruti Sharma shall be included in the 'Promoter Category' rather than 'Public Category'. As the Company has preferred an appeal against this order before the Hon'ble SAT, hence shareholding of Mr. Shreyas Sharma and Ms. Shruti Sharma is continued in 'Public Category'. 4. As per Regulation74(4) of SEBI (ICDR) Regulations, 2009, all new equity shares allotted under preferential issue are to be issued in dematerialised form, hence shares allotted as discribed above are included in "Number of shares held in dematerialized form".
